## MSHA UNVEILS NEW SAFETY CAMPAIGN



This past February, MSHA launched a new campaign in response to the recent increase in mine fatalities and injuries. The campaign “Take Time – Save Lives”, is aimed at reminding mine operators to train miners and ensure they can take their time to prevent accidents/injuries and to save lives.

According to MSHA, many of the recent incidents could have been prevented with proper training and attention to tasks. It is up to mine operators to ensure that miners are fully trained and able to take time to follow best safety practices that can prevent deadly accidents.

Mines across the country will receive a poster to display at mine sites with steps they can take to stay safe. ## NATIONAL FALL PREVENTION STANDDOWN SET FOR MAY 2-6, 2022

The ninth annual National Safety Stand-Down to Prevent Falls in Construction is scheduled to take place May 2nd through May 6th. The nationwide event is aimed at preventing fall-related deaths and injuries by increasing awareness of fall hazards.

According to the Bureau of Labor Statistics, falls from elevation continue to be a significant cause of fatalities, accounting for 351 of the 1,008 construction fatalities recorded in 2020.

The Stand-Down is a voluntary event in which companies can conduct a Safety Stand-Down by taking a break to have a toolbox talk or another safety activity such as conducting safety equipment inspections, developing rescue plans, or discussing job specific fall hazards.

Employers will be able to provide feedback about their Stand-Down and download a Certificate of Participation following the Stand-Down.
